

Data Privacy Policy

We place great importance on the safe handling of your personal data. The protection of your data submitted and the correct use of such data obtains top priority for us. As a matter of course we act strictly in compliance with the German Data Protection Act as well as the German Telemediengesetz. Therefore we would like to give you a closer understanding of the process of data storage and its subsequent use. This Data Privacy Policy does not apply to links to other websites owned by third parties not being part of the uvex group of companies.

Data acquisition

Your visit on our website will be logged by an external service provider whereas date, time, settings of your internet browser, subpages visited and average time spent there as well as your IP address will be recorded. In general it is neither possible nor desired to attribute the logged data to a concrete person. Such anonymous data is used to monitor the attractiveness of our website and to continuously improve its content in order to offer the best service for our customers. More information with respect to the logging service provider is available in the imprint section. There is no further data interpretation nor forwarding to third parties.

Moreover personal data will only be stored in case you voluntarily submit it within the scope of a registration, an online application or for reasons of implementing a contract. The corresponding web form will inform you about the intention of the data acquisition.

Data processing

Personal data which you submitted by email or through our website will solely be used for correspondence with you and is exclusively processed for the purpose you intended when submitting the data. Submitted data will be only forwarded to the departments in charge, if necessary to other companies being part of the uvex group of companies.

We assure not to forward your personal data to third parties except for legal requirements.

Data storage

Submitted data will be stored until the purpose for which you disclosed it is served. Should regulatory safekeeping periods exist such periods will be observed.

In case you do not longer agree with the storage of your personal data we will delete it on first demand provided that the storage is not required by law. Whenever your personal data changes we will amend the stored data as soon as you informed us.

Cookies

Cookies are small text files which are transferred to the hard disk of your computer via your web browser. Cookies are transferred for reasons of controlling the connection or to provide you with more individual comfort during the visit of our website.

We currently use “non-persistent session cookies” which means that the cookies will be deleted when you close your browser and therewith end the session. By changing the settings of your internet browser you may limit or prohibit the acceptance of cookies as well as set forth that cookies will only be accepted after your prior approval.

Disclosure of stored data

You may at any time request the disclosure of the stored data concerning yourself. Please be so kind as to contact our Data Protection Officer in writing and include proof of your identity (copy of your identity card or passport).

Amendment of the Data Privacy Policy

We expressly reserve the right to alter this Policy. In case of a launch of new products, changes of our internet presence, amendments to the statutory regulations or enhancements of the IT safety technology, this Data Privacy Policy will be amended. Therefore it is recommended that you regularly visit our website to be updated.
